DISTRICT COURT 09-5-17 VII

The following resolution was submitted for approval.

Moved by Councilmember Marshall Supported by Council Pro Tem McDonald At a meeting of the Highland Park, Michigan City Council held on Tuesday, September 5, 2017 with an opportunity for the District Judge to be heard and questions to be posed, and the council being otherwise informed, the council finds the following:

WHEREAS the 30th District Court handles most traffic violations, all civil cases with claims up to \$25,000, landlord-tenant matters, most traffic tickets, all misdemeanor criminal cases, felony arraignments, felony probable cause conferences, and felony preliminary examinations. In addition, small claims cases are heard by a division of the district court

WHEREAS the funding unit is responsible for funding its district court to ensure that it complies with its responsibilities as outlined by the Michigan Constitution

WHEREAS four line items in the 30th District Court's budget have been underbudgeted and will not meet the courts reasonable and necessary needs to function, specifically: the medical opt-out line-item which saves the local funding unit in health care expenses for the courts full-time employees, technical support needed for the court's numerous electronic platforms, salaries for the court's employees which if not modified will not meet the court's audit guidelines as it relates to the reorganization/hiring plan accepted by the State Supreme Court Administrative Offices, and optical benefits for those full-time employees who are eligible to receive.

NOW THEREFORE BE IT RESOLVED that the Highland Park City Council, amends the 30th District Court's budget line-items as follows: salaries- \$422,059, Medical Opt-out- \$3,600, Tech Support- \$2,000, Optical Benefits- \$737.52 for a total increase from the present 30th District Court budget of \$22,847. WHEREAS, the Sell's Equipment Quote ID#15878210, to provide the City of Highland Park with three 5055E Utility Tractors and 3 MX6 Lift-Type Rotary Cutters for the sum of \$66,397.05, represents the best value in equipment and provides significant savings when compared to all other bids submitted.

The following communication was received from Louise Tutt regarding 65 W. Buena Vista.

Greetings,

This email is to get an issue addressed at the next city council meeting Sept 5th 2017.

I need to purchase a lot in HP. I am the owner of an adjacent property and I was denied. I was able to aquire 4 lots in area and 5 in Detroit, each one taking no more than a few days to get from the State or County. I'm in the process now of getting the deeds. I've never seen a process like the one in HP. Also, the Wayne County tax office told me that its Not transparent (by Highland Park) that its legal to deny me for the reasons listed. I was told to contact the state Attorney General about this process.

I just want the property approved to be released to me and I would like for all city information, charters, and processes to be public information on the website.

There is no legitimate reason I should have any issues with this city, when I was able to accomplish the same things with larger cities and counties in less time.

My address is 67 W Buena Vista. The gate to my yard technically surrounds 65 W Buena Vista, even though it looks like one yard. I want to start working on the yard and I want to legal own the space.

Wayne County has a process and I was able to get a few properties in a matter of days. Most people I speak to around the nation are able to do a process that is transparent and easy. The Highland Park process was on hold with little to no explanation.

Problem:

I was denied the 65 W Buena Vista lot purchase. Its not in the cities best interest to prevent me from getting the lot.

Two reasons listed for being denied are- I don't own 67 W Buena and there is Taxes owed on the property.

1) You don't have to own the house to purchase a lot.

2) I do own the house and turned the deed into the Housing Window in the city building.

3) I went to Wayne County to make a Tax plan. The home isn't in forclosure. When I spoke with Wayne County they said its not legal to deny based on that and I should contact the state AG.

4) I only recently purchased the home, so I am paying taxes owed at the moment.

5) I have the deed to 63 W Buena Vista and 67.... So its in my interest and the citie's interest to sell me the lot in the middle of my property.

Solution: Sell me the lot immediately. I will not be filling out (and paying for) another application.
