RESOLUTION FROM THE HIGHLAND PARK CITY COUNCIL IN ITS OFFICIAL CAPACITY REQUESTING THE MICHIGAN SECRETARY OF STATE JOCELYN BENSON AND THE MICHIGAN STATE ATTORNEY GENERAL DANA NESSAL PROVIDE OFFICIAL STATE MONITORS TO OVERSEE, MONITOR AND INTERVENE, WHEN NEEDED, THE MOVEMENTS AND DECISIONS MADE BY THE CITY OF HIGHLAND PARK ELECTION COMMISSION PRIOR TO, DURING AND POST ELECTION CYCLE FOR THE UPCOMING NOVEMBER 8TH, 2022 GENERAL ELECTION

WHEREAS, the residents of the City of Highland Park will participate in the Legal Voting Process for municipal, county and statewide elected positions/proposals and the WILL of the people (residents) of the City of Highland Park must be respected and accepted, and,

WHEREAS, the Highland Park City Attorney Terry Ford attending a City Council meeting in May of 2021, threaten Warrants for the Arrest of every City Councilmember after the City Council denied his request for a Contract Renewal based on a 'Vote of No Confidence', and,

WHEREAS, the Highland Park City Attorney Terry Ford has displayed a posture of 'Retribution' towards the Highland Park City Council since that Contract Renewal was denied and its Vote of No Confidence, and,

WHEREAS, this Retribution has included (1) hiding contractual information from the Highland Park City Council (2) not providing litigation updates to the Highland Park City Council (3) not providing explanations of expenditures from the Department of Law in excess of six-figures and most recently (4) denying City Councilman/Candidate Ken Bates from being placed on the November 8th, 2022 General Election ballot, even though his case mirrored a very recent case in which the Court determine a local candidate can remain on the ballot for the exact same affidavit language as Ken Bates, (Please note* by City Charter, the City Attorney is the Chairman of the Highland Park Election Commission) and,

WHEREAS, the integrity, impartialness and objectivity of the Highland Park Election Commission has been compromised by the unprofessional behavior of the Highland Park City Attorney and other Election Commissioners and,

WHEREAS, a Highland Park Election Commissioner/Employee of the City has been identified through attached evidence of supporting, endorsing and campaigning for a candidate vying for the position of Mayor of Highland Park, which is prohibited by both the Election Commission and Chapter 12 Elections, Section 12-12 Political Activities Prohibited of the Highland Park City Charter, and,

WHEREAS, the Highland Park City Council has NO CONFIDENCE in the ability of City Attorney/Election Commission Chairman Terry Ford to oversee, without personal intervention, a fair and impartial municipal election for the voting residents of the City of Highland Park during the November 8th, 2022 General Election,

NOW, THEREFORE BE IT RESOLVED, that the Highland Park City Council formally and officially requests that the Secretary of State Jocelyn Benson and Michigan State Attorney General Dana Nessel provide monitors to oversee, monitor and intervene (when needed) the movements and decisions made by the City of Highland Park Election Commission prior to, during and postelection cycle for the upcoming November 8th, 2022 General Election and a copy of this Resolution be sent to our State Representative, our State Senator and the Governor's Office. A RESOLUTION SUBMIT APPLICATION FOR NEIGHBORHOOD ENHANCEMENT PROGRAM (NEP) GRANT

WHEREAS, MSHDA announced Round 8 of the Neighborhood Enhancement Program (NEP) that will provide up to Two Million Dollars in MSHDA funding statewide for activities directly tied to stabilization and enhancement of Michigan's rural communities and urban neighborhoods; and

WHEREAS, the program's intent is to fund tangible housing-oriented activities that are: implementation ready; highly visible; impactful to the area and resident's quality of life; and where there is buy-in and demonstrated support within the area and where people are engaged and facilitating change; and

WHEREAS, cities may request up to \$75,000 with at least 50% going towards exterior renovations in a selected neighborhood; and

WHEREAS, the City desires to apply for funding in line with its goal to create a livable and sustainable community by providing a high quality of life for all citizens. while retaining the city's historic character and creating opportunities for new investment; and

NOW, THEREFORE, BE IT RESOLVED, that the City approves applying for Round Eight of the Neighborhood Enhancement Program (NEP). Yeas (4), Nays (0), Absent (1) Patrick.

EMERGENCY RESOLUTION TO REPAIR PLUMBING AT 13233 HAMILTON

WHEREAS, the water leak issue from the plumbing/roof must be fixed before it causes more damage; and

NOW, THEREFORE, BE IT RESOLVED that the City approves hiring the John Greene Company to make emergency plumbing repairs at 13233 Hamilton at a cost not to exceed \$10,500. Yeas (4), Nays (0), Absent (1) Patrick.

RESOLUTION TO ACCEPT THE GIFT OF TREES VALUED AT \$48,000 FROM THE GREENING OF DETROIT

WHEREAS, The Greening of Detroit, 13000 McNichols, Detroit, M1 48235 has offered to purchase and install up to 60 shade and ornamental trees (1.5" caliper balled and burlap); and

WHEREAS, the trees will be planted in Glendale Park, 51 Glendale Avenue and at the Ford Recreation Center/Ives Field, 10 Pitkin Street; and

WHEREAS, the easement at Perchman Park, 13099 John R, will be considered as time allows, and is included in the total number of trees above; and

WHEREAS, the cost, approximately \$48,000, is being borne by The Greening of Detroit; and

WHEREAS, planting of these 60 shades and ornamental trees will take place during the Fall 2022 planting season; and

WHEREAS, the Greening of Detroit will provide a 3-year maintenance plan that includes 2 years irrigation, and the first structural pruning of these trees; and

WHEREAS, no warranty is provided, but any trees that have died within the first two years can be removed (flush cut) at the request of the Parks and Recreation Department, and

NOW THEREFORE, BE IT RESOLVED, that the City gratefully accepts the donation of 60 trees, plus 3-year maintenance from The Greening of Detroit. Yeas (4), Nays (0), Absent (1) Patrick.
