WHEREAS, the Highland Park City Council would like to formally recognize the contributions of the Honorable Commissioner Martha G. Scott to the City of Highland Park for over eighty years; and

**WHEREAS,** The Honorable Commissioner Martha G. Scott began her political career as a Precinct Delegate for District 3 in the City of Highland Park in 1972, was appointed Wayne County Commissioner in 1977; and

**WHEREAS,** The Honorable Martha G. Scott was elected President of the Highland Park City Council in 1984, and in 1988 became the Mayor of the City of Highland Park; and

WHEREAS, The Honorable Martha G. Scott was elected State Representative in 1994, to the State Senate in 2000 and again in 2010 was elected Wayne County Commissioner, a position of leadership that she still holds.

**NOW, THEREFORE, BE IT RESOLVED,** that the Highland Park City Council now declares Rhode Island Street to now and forever also be known as Martha G. Scott Boulevard, and such honor shall be memorialized by the placement of a street sign indicating such on the corner of Woodward Avenue and Rhode Island Street. Yeas (5), Nays (0), Absent (0).

RESOLUTION REQUESTING AUTHORIZATION FOR THE CITY OF HIGHLAND PARK WATER DEPARTMENT, IN COORDINATION WITH THE HIGHLAND PARK DEPARTMENT OF PUBLIC WORKS, TO PREPARE A VULNERABILITY ASSESSMENT FOR THE HIGHLAND PARK WATER TREATMEN PLANT

**WHEREAS**, the City of Highland Park Water Treatment Plant is located outside of the City Boundary, in the City of Detroit, has been subject to multiple vandalism attempts, and has had other considerable security threats since its closure in 2012; and

**WHEREAS**, it is necessary for the City of Highland Park to secure the Water Treatment Plant property from the public to minimize or eliminate future security threats to the City owned property; and

WHEREAS, Mance Consulting, LLC has submitted a proposal as part the Water Department's overall responsibility of water assets, as well as the Department of Public Works' (DPW) facility management responsibility, under existed budgeted funds from the departments, for a Security Threat Assessment for the City of Highland Park Water Treatment Plant Site, where objectives include identifying potential threats, assessing vulnerabilities in current infrastructure, personnel, and public safety, and recommend mitigation strategies to the City of Highland Park; and

**BE IT RESOLVED,** the City of Highland Park City Water Department, in coordination with the Department of Public Works, shall be authorized to prepare a vulnerability assessment for the Highland Park Water Treatment Plant. Yeas (4), Nays (1) Robinson, Absent (0).
