RE: Greening Community Planting Program

The Highland Park United Neighborhood Association (HPUNA) has been granted 160 trees by Greening of Detroit to be planted in the 2<sup>nd</sup> Phase of the Greening Community Tree Planting Program.

You are receiving this notice to request that this project be placed on the agenda for the city council meeting of September 8, 2015. The residents that may receive the trees need the approval of city council as the trees will be planted on the public space between the sidewalk and curb in front of certain homes (see attached list). The sites have been targeted based upon resident requests, Greening of Detroit requirements, and coordination with DPW. Residents will be invited to attend a meeting with Greening of Detroit and city representatives where the entire project will be explained.

Greening of Detroit would like to plant the trees on October 24 and 31, 2015. Greening of Detroit provides technical assistance and some watering to assist during the first year after planting. Residents may be needed to supplement Greening of Detroit's watering schedule if we have a dry summer next year.

Greening of Detroit provides a forester who has assessed sites to determine their feasibility for tree planting, and will provide a variety of trees to prevent the spread of disease that wipes out one specific type of tree, such as the Dutch Elm disease that killed many of Highland Park's trees. Some trees will be ornamental trees. Others will be shade trees, depending on the characteristics of each location. None of the trees will interfere with existing infrastructure.

The first phase planting in this program occurred in the Spring, 2014 on Tennyson, Connecticut, California and Massachusetts. The second phase planting is scheduled to occur on Massachusetts, McLean, Farrand Park, Winona, Puritan and Moss.

The HPUNA is a non-profit membership based organization incorporated to assist block clubs and block leaders to work together with city government to initiate self help projects that will improve the cleanliness, safety and quality of neighborhoods in Highland Park. HPUNA is serving as the facilitator of this project.

Trees add many benefits to a community – improve the air quality, increase property values, improve the esthetics, etc. Mayor Windom and the Highland Park United Neighborhood Association look forward to city council's participation in this effort to improve the quality of life in Highland Park.
